GENERAL INFORMATION

Braintree Golf Course welcomes golf outings from 12 players to 72 players. Our professional staff is experienced and prepared to service all of your requirements and outing needs. The course is available Monday through Sunday anytime.

To reserve a date, we require credit card on file as a security deposit .Any damage done to the course or golf carts will be charged to that credit card. A contract will be issued confirming the date of play and the number of players for your outing. Player count can be reduced subject to the following restrictions:

- Player count must be finalized at least 7 days prior to the scheduled date of outing_____
- Final payment must be in even foursomes_____

*Materials for longest drive and closest to the pin will be made available.

PLAYER INFORMATION

The following information should be included in the initial invitation to participant golfers.

- **Golfer must register at least 25 minutes prior to scheduled tee times.**
- Proper golfing attire is required.
- No spectators are allowed.
- No food or beverage of any type can be brought onto Braintree Golf Course property by the group. No open containers of alcohol in the parking lots at any time.

GOLF CARTS

Golf carts are not included in price of greens fees.

Carts are \$20 per golfer and will be available the day of your outing.

Deposits and Contracts

The reserved date is official **only** after we have received a signed contract along with a Credit Card # as a deposit. This deposit serves to guarantee your tee times and the amount of golfers. A guaranteed count must be received 7 days prior to outing. You will be charged for the total number of players that are confirmed 7 days before.

- Players must follow rules of the course as posted.
- Players must keep up with the group in front of them.
- Any damage to the golf course or carts will be the responsibility of the undersigned and will be charge to the credit card provided.
- If golf course is open for play with carts, despite weather conditions, the outing must take place.
- **Before the tournament is allowed to “tee off”, the Tournament Coordinator must confirm the number of golfers and pay for the cost of the number of players agreed to with the golf professional. One person pays for the entire group. No individual payers.**
